**I. Call to Order**

**II. Approval of March Meeting Minutes**

Stacy Stein moved to approve the minutes as presented. Todd Halvorsen seconded the motion and it passed.

**III. Featured Presentation**

A presentation was made by Tammy Teixeira, Assistant Director, Enrollment Development at CSUEB regarding enrollment policies for incoming freshmen as well as for transfer students. Highlights of her presentation:

- application window of 10/1-11/30/11 for acceptance for 2012-13 school year
- \$55 application fee for all CSU schools but students will be screened for a fee waiver. If approved, they can apply for four CSU schools for free.
- CSUEB offers “on the spot” enrollment through career center visitation for high school seniors.
- there are 23 CSU campuses, many are impacted or have impacted majors (CSUEB has two: nursing and business). CSUEB is currently impacted for transfer students but this does not impact student sin our community. Students need to meet minimum requirements for EB but may have higher requirements if their major is impacted.
- how to plan for and apply to a CSU in three easy steps: [www.csumentor.edu](http://www.csumentor.edu), college planner, explore majors and financial aid
- [www.assist.org](http://www.assist.org) – website for information on transferrable courses; valuable due to impacted majors; very important

- students may be take SAT or ACT and CSU will take highest CR and math SAT score with no penalty for taking more than once
- AP tests with a score of 3 or better qualify for college credit
- CSUEB has no unit limits; some reports of other campuses having limits
- CSU system is not offering summer starts
- placement tests for English and math are available locally
