Appeals are based on extenuating circumstances. Additionally, where a student with a disability applied for, but did not receive timely, reasonable accommodation an appeal may be filled. Students may also appeal their loss of priority registration status due to earning 100 or more degree-applicable semester units in Chabot-Las Positas Community College District (CLPCCD). A student who successfully appeals their loss of priority registration status shall also have their BOG Fee Waiver eligibility restored.

To appeal your loss of priority registration status and/or your loss of BOG Fee Waiver, return this completed petition with supporting documentation to the Counseling Department (1st Floor, Building 1600) or to your Special Program Counselor. You will be notified of the outcome via your Zonemail email account approximately 15 business days following receipt of your request.
